

ATTORNEY ROSTER COVER PAGE

This document explains the process for appointing counsel to provide representation to a parent in a case initiated by a private party seeking a termination of parental rights

IDC Attorney Roster:

The Utah Indigent Defense Commission (IDC) approved roster identifies attorneys qualified for appointment to represent indigent parents in privately initiated termination of parental rights/adoption cases in both district and juvenile courts

Appointment by the Court:

The judicial assistant for the judge making an appointment should contact the rostered attorneys to identify one who is available to accept the appointment and then notify the judge

If the court is unable to locate an attorney willing to accept the appointment, the judicial assistant may contact Adam Trupp at the IDC to request help locating an available attorney

Attorney Accepting Appointment:

Immediately after accepting an appointment, attorneys must:

- Notify the county and provide the court's notice of appointment to the county
- Ensure they have contracted with the county for this representation work

Attorney Declining Appointment:

If an appointment needs to be declined, attorneys must:

- Contact the court to provide notice that they are declining the appointment
- Inform the county where the case is being handled
- File a notice of declination or withdrawal if required by the court

Appeals:

This process does not apply to the appointment of appellate counsel for cases from either district or juvenile court.

Reimbursement Rates:

- Attorney Fees \$75/h
- Paralegal Services \$40/h

- Defense Resources \$500 (per transaction, not per case). Defense Resources include investigators, experts, evaluations, subpoenas, transcripts, record requests, forensic tests, and witness fees. Costs anticipated to exceed \$500 require pre-authorization from the county.
- Travel expenses may be reimbursed only when travel distance is 50 miles or more round trip.
- \$75/hr attorney travel time
- State mileage reimbursement rate is currently \$0.44 per mile.
- Hotel fees at the State rate for trials only at \$500.00 cap per case (overages require preauthorization from the County)

Payment / Invoicing:

Attorneys must submit the following documentation to the County within 10 days following the end of each month:

- Monthly invoices, using the Attorney Invoice Form or your own itemized invoice. A DefenderData or a similar itemized report showing tasks and time spent on them is recommended as support documentation.
- Orders of Appointment or Substitution of Counsel
- If applicable, itemized invoices and itemized receipts from defense resource vendor(s), Defense Resource Overage Pre-Authorization Form, or Travel Expense Overage Pre-Authorization Form.

Malpractice Insurance:

- Malpractice Insurance is required as stated in Section 2.5 of the Attorney Contract
- Each County may determine their respective coverage limits requirements
- The Utah State Bar has endorsed the malpractice insurance provider, ALPS

Appeals:

This roster does not apply to cases on appeal. Appointed counsel must comply with the requirements of Utah Rule of Appellate Procedure 38B before being appointed as counsel on appeal.
